#### Candidate Statement

Hello, my name is Matt Cooper and I have been teaching part-time here at Eastern Michigan University since 2008. I am happy and proud to say that I was a part of the union recognition campaign for part-time lecturers back in 2010. What started out as a grassroots movement for 600 people who had no say on campus, and little recognition as a group, has turned into a member-driven union where members now have more job security and a stronger voice at the bargaining table.

As a union of part-time and full time lecturers, we have accomplished so much in such a short period of time. Before we had our first collective bargaining agreement there were members making only \$700 a credit hour with no guaranteed raise. Now all members have to make at least \$1160 per credit hour, and annual raises are now included in our contract.

Recently, when several of our full-time members were laid off from the College of Education, I'm proud to say that I was there tabling and petitioning alongside the members from the COE and other departments. This was a great moment because not only were we fighting for our colleagues' jobs but also for our future student teachers who have been affected by changes in the COE. Because of pressure from EMUFT, many of these lecturers have since been hired back.

And finally, I was on the organizing team that fought EMU on their stance of hiring from outside of the bargaining unit before asking the hard working lectures in the math department if they wanted additional class assignments. We took EMU to arbitration and won, thus strengthening job security for lecturers across campus just a little bit more.

But as much as we have accomplished, we have so much more to do to make this a better place to teach, and most importantly, a better place for our students to learn. Together we are stronger. I look forward to working with you on our future challenges, and I hope you will vote for me for Vice President.

In 2010 with high hopes and expectations, EMU's part-time contingent faculty joined with their full-time lecturer colleagues to fight for and win a 600 member strong union. Today, an increasingly recalcitrant EMU Administration and lackluster Union leadership have eroded many of those hopes and expectations.
